

# Investall Privacy Policy

This privacy policy (“Policy”) discloses the privacy practices for Investall.app. This privacy policy applies solely to information collected by this web site. It will notify you of the following:

What personally identifiable information is collected from you through the web site, how it is used and with whom it may be shared.

What choices are available to you regarding the use of your data.

The security procedures in place to protect the misuse of your information.

How you can correct any inaccuracies in the information.

Personal data received or transferred to our website is subject to the regulatory enforcement powers of the U.S. Federal Trade Commission. The Company restricts access to the information to their employees who need to know the information to provide services to the Company, and maintain physical, electronic, and procedural safeguards that comply with U.S. federal standards to guard the information.
